**DECLARATION OF K. SCOTT WAGNER FILED ON BEHALF OF MALLERY, S.C. IN
SUPPORT OF APPLICATION FOR AWARD OF ATTORNEYS' FEES AND
EXPENSES**

I, K. Scott Wagner, declare as follows:

1. I am a shareholder in the firm Mallery, s.c. ("Mallery" or the "Firm"). I am submitting this declaration in support of my Firm's application for an award of attorneys' fees, expenses and charges ("expenses") in connection with services rendered in the above-entitled action (the "Action").

2. Mallery is counsel of record for Gabriel Yandoli and Bucks County Employees Retirement System ("State Court Plaintiffs") and court-appointed Interim Class Liaison Counsel in a consolidated securities class action pending in Waukesha County Circuit Court for the State of Wisconsin styled *Gabriel Yandoli et al. v. REV Group, Inc. et al.*, Consol. Case No. 2018CV001163. On May 19, 2021, State Court Plaintiffs and the Houston Municipal Employees Pension System, on behalf of itself and all others similarly situated, entered into a Stipulation and Agreement of Settlement with Defendants, which was filed in this Court. Prior to becoming part of Mallery, I was a shareholder at the law firm of Mallery & Zimmerman, S.C which also served

as liaison counsel for the Class. For a short period of time, my prior firm of Kerkman, Wagner & Dunn served as local counsel in the State Court action before I left that firm to join Mallery & Zimmerman. All of Kerkman, Wagner & Dunn's interest in the action has been conveyed to Mallery through my contractual agreement with that firm and all of Kerkman Wagner & Dunn's fees and expenses are included in this declaration as part of the time and expenses incurred by Mallery. Similarly, Mallery also has all rights and interests that formerly belonged to Mallery & Zimmerman regarding this matter and its fees and expenses.

3. The information in this declaration regarding the Firm's time and expenses is taken from time and expense reports and supporting documentation prepared and/or maintained by the Firm in the ordinary course of business. I am the shareholder who oversaw and/or conducted the day-to-day activities in the Action since its inception and I reviewed these reports (and backup documentation where necessary or appropriate) in connection with the preparation of this declaration. The purpose of this review was to confirm both the accuracy of the entries on the printouts as well as the necessity for, and reasonableness of, the time and expenses committed to the Action. As a result of this review, reductions were made to both time and expenses in the exercise of billing judgment. Based on this review and the adjustments made, I believe that the time reflected in the Firm's lodestar calculation and the expenses for which payment is sought herein are reasonable and were necessary for the effective and efficient prosecution and resolution of the Action. In addition, I believe that these expenses are reasonable and were necessary for the effective and efficient prosecution and resolution of the Action.

4. After the reductions referred to above, the number of hours spent on the Action by the Firm is 190.3. The lodestar amount for attorney/paraprofessional time based on the Firm's

2021 rates are \$79,827.50. The chart below accurately sets forth the lodestar calculation described herein:

5. The hourly rates shown in the chart above are the Firm's current hourly rates as set by the Firm for each individual. These hourly rates are consistent with hourly rates charged by the Firm during 2021 to its clients and are well within the commercially reasonable range of rates for similar firms in the Metropolitan Milwaukee area. In cases where the listed personnel are no longer with the Firm, the hourly rate listed is the rate charged by that timekeeper immediately prior to their departure from the Firm.

6. The Firm seeks reimbursement of \$4,451.18 in expenses and charges in connection with the prosecution of the Action. Those expenses and charges are summarized by category as follows:
